# OUR COUNSELLING IS FREE OF CHARGE

We offer counselling and support to victims of domestic violence and stalking. You can talk about your situation and problems and ask questions. Only you decide what you want to discuss. Together with you, solutions and ways out of the violent situation are looked for.

## You are affected by domestic violence or stalking if:

- you are insulted, blackmailed and bad-mouthed to others
- you are forbidden to meet family, girlfriends or friends
- you are locked up
- your money is taken away from you and/or is controlled
- your things are damaged
- you are threatened that you or your children are harmed
- you are hit, pushed, kicked or otherwise hurt
- you are forced to perform sexual acts
- a separation is not accepted, no (further) contact is desired, you are harassed or persecuted.

## Consultations by appointment - so that we can take time for your concerns.

You can also use our counselling service if you currently do not want to separate from your partner.

We also provide counselling if a friend, relative, acquaintance, work colleague or client of yours is affected.

# WHAT YOU CAN DO IN AN EMERGENCY

If your spouse, partner, friend, acquaintance, son, father or roommate

### is violent, call the police 110

The police can expel the offender from the shared flat or house for up to two weeks (expulsion).

#### Important: Documentation of injuries!

Have your injuries treated and documented by a doctor.

This is also possible online at www.forensisches-konsil-giessen.de

The Forensic Konsil Gießen (forensic medicine) offers victims the possibility to write down old and fresh injuries such as wounds, bruises or scars in a "forensic" way. This makes it possible to report the offences later.

In addition, an application under the Protection against Violence Act can be filed with the family court for further protection. Then the perpetrator can be prohibited from

- approaching you, the flat or the house within a certain radius
- going to places where you regularly spend time, for example your workplace, school, kindergarten, supermarket, etc.
- calling you, writing you messages or contacting you in any other way.

### **WOMEN'S SHELTER**

If you do not feel safe in your flat or the house and you are afraid and cannot stay there, there is in addition to our counselling service also the possibility of moving into a room in the women's shelter.

Our Advice and Intervention Centre against domestic violence is jointly financed by the state of Hesse, the Lahn-Dill district, the city of Wetzlar and the Frauenhaus Wetzlar e. V. association.
